Advisor's services and fees page appearing on this website are incorporated herein by reference and **Client** is encouraged to print a copy of that page at the time of signing. It is understood and agreed that the services and fees listed on said page are not exhaustive, and that they are also subject to change.

For the different services **Advisor** provides, **Client** will be provided with a written quote, unless time does not permit it, in which case, **Client** will get a verbal quote, either one of which would be for **Client's** approval and authorization to move forward.

Once **Client** authorizes a booking or purchase, **Client** shall promptly provide a credit card for payment, if such is needed, and shall then be responsible for any penalties or fees that may be attached by the provider of the services if **Client** fails to comply with their rules, in addition to any of **Advisor's** fees that may apply.

Advisor will initially ask **Client** for some of **Client's** personal information. It is **Client's** responsibility to make sure that **Client** has given **Advisor** **Client's** correct name, as well as other personal information, as such appears on **Client's** passport or any other identification **Client** may be using for traveling. It is also **Client's** responsibility to review the quotes, whether written or oral, to ascertain that **Advisor** has used the correct information.

Advisor has insurance available for sale for **Client's** trip, to cover medical expenses, trip cancellation and repatriation, among other coverages, subject to provider's limitations. **Client** shall indicate below by entering **Client's** initials and the date whether **Client** is rejecting insurance for his/her trip or whether **Client** is accepting the offer to receive an insurance quote.
